

Joint Message from the **Executive Director** and **Chair of the Board of Directors**

This year at Alice House has been particularly significant, as we welcomed a new Executive Director and entered the final year of our strategic plan. Much has changed about the world around us since that planning, particularly with respect to the cost of living, housing landscape and domestic violence advocacy. We've relied on our community, our resilience to adapt to a rapidly changing world and ground in our values, and in our 40-year history of commitment to the safety of Nova Scotian women and children.

During times of transition, go back to basics. When women first come to Alice House, this is a core principle we teach, a principle that has found resonance during our own organizational transition. Embracing this approach, we have examined our processes, procedures, team structure, and capacity to ensure we are well prepared for the next iteration of strategic planning and impact.

In addition to our operational assessment, we invested significantly in our capital infrastructure. These investments included the completion of comprehensive Building Condition Assessments conducted on each of our residential properties and Drop-in Centre. These assessments inform projections of building maintenance and long-term use opportunities for our assets to continue to expand our impact.

In less fortunate news, we suffered significant damage to our largest multi-unit residential complex following a collapsed roof and downpour flooding during the 2023 Nova Scotia Floods. The outpouring of support to fund these renovations and assist with the safe displacement

of the women and children occupying damaged units was overwhelming and heartening, underscoring the community spirit that drives us forward. After nearly four months of construction, we are proudly operating at full housing capacity with refreshed units.

Finally, despite our best efforts and an expanded housing support team, women are increasingly experiencing bottlenecks in moving out of Alice House residences. They prepare to transition to long-term housing equipped with established safety and independence only to find a lack of adequate and affordable rental options. The demand for safe, affordable housing solutions is more urgent than ever, and the need for continued community education of the epidemic-level impact of domestic violence remains critical. We remain committed to addressing these issues through innovative approaches, compassionate support and unwavering advocacy for our clients, and we know our greatest impact will be achieved through collaborative partnerships with all corners of community and government.

We will continue to provide a sanctuary for safety, healing and independence for women and children recovering from domestic violence while we work towards a world where Alice House is no longer needed. We can't thank you enough for your continued support and partnership.

New Program Spotlight: Growing Together

Alice House secured multi-year funding to create an online education program for service providers who work with young children (ages o to 4) and their parents affected by domestic violence. In the first year of program design, Alice House initiated community consultations and conducted literature research to inform the development of a 4-module program.
