### Message from our Executive Director

2018-2019 was another year of growth and change for Alice House. As our programming continues to evolve to suit the needs of the families we serve, so does our organization as a whole.

We had a focus on education as a form of prevention in the past fiscal with wonderful results. We provided workshops and education to over 2500 people ranging from students to seniors groups. We expanded our social media profile tripling our Facebook followers and had information posts shared thousands of times.

After community consultation and feedback we changed the name of our well known program for children and youth "Healing the Bruises" to "Healing Hearts". The program is the same, providing comprehensive counselling support for children exposed to domestic violence and everyday we are encouraged by the recovery and success of the children and youth who come through it.

Our programming for women recovering from domestic violence expanded beyond our housing and services offered to clients living externally. This endeavour highlighted the need for more services and will be explored through a strategic planning endeavour, Alice House will be taking in 2019-2020.

We are grateful for the ongoing community trust and support so that we can provide these services in our community. Royal LePage Atlantic, the Nova Scotia Advisory Council on the Status of Women, United Way of Halifax, Telus Community Foundation, the Mental Health Foundation and so many other community champions (see pages 15-20) who insist that women and children have a safe place to call home. I want to send a profound thank you to the power-house team of women who worked at Alice House last year and supported so many. Your commitment to Alice House, it's mission and every woman who calls looking for help, inspires me every day.

Our fundraising activities this year included a Stay-at-Home event and our ongoing partnership with Atlantic University Sport to sell 50/50 tickets at the basketball championship. We thank all of the volunteers and donors who helped make these events successful. We were also very pleased to see an increase in third party fundraisers in support of Alice House.

The Board of Directors saw some changes this year, welcoming Donna Gallant, David Davidson and Sarah Simpson and bidding farewell to Meaghan Blyth and Sophie Richer. Terms will expire for co-chair Theresa Hawkesworth, Tsege Gebreyohannes and Rob Weld at our AGM in June. We thank our departing Board members for their contributions and wish them well.

## Information about Domestic Violence

- Women continue to be the predominant victims of domestic violence in Nova Scotia\*
- Women who leave a partner to raise children on her own are 5× more likely to live in poverty than if they stay.<sup>†</sup>
- Between 1996 and 2015, 40 women were murdered by their intimate partner in Nova Scotia.\*
- Women are significantly more at risk for future violence when they leave or attempt to leave the relationship.

- 212 women called identifying themselves as victims of domestic violence and seeking services.
  - Received 413 calls from the community looking for information about intimate partner violence, education, resources, and referrals.
    - 186 referrals were made to other community and government resources.
      - Phone and drop in support for current and past Alice House clients provided over 1000 times.
      - Consulted with government about victims of domestic violence on 68 occasions.

• Increased our community reach through social media sources with 300% increase in followers and subscribers.

A life without safety is a life without basic needs being met. Despite this, individuals often remain in abusive situations because they have no where to go and because their fear even more violence if they leave. In response to this, a brave group of women created Alice House which opened it's doors in 1983.

Alice House provides opportunities for women and their children to create a life free from intimate partner violence by offering safe housing, counselling and support services. Since that time, close to 1400 families have called Alice House home.

### **Our Programs**

**Housing:** Alice House provides housing options for women who are fleeing abusive relationships and fear more violence if they leave. Our houses include safety features including alarms, security cameras and kick proof doors. We work with clients to build credit, manage household expenses and start over. When necessary and through the support of community partners, we can also fully equip her household with everything she and her family needs to start over. We have 18 housing units across HRM and families stay with us for approximately one year.

#### In 2018-2019

- 32 families transitioned through to safety calling Alice House home.
- 822 times AH provided access to food and personal care items.
- 183 instances of support and advocacy acquiring utilities, supplemental income, budget supports, acquiring long term housing and transitioning out of Alice House.
- 60% of families required furnishings and supplies to help rebuild what was lost when they fled.

"Without such programs and services made to women like myself, I strongly believe my mental health and well-being would have deteriorated to a point where my children would no longer have a functioning mother who is present and able to enjoy life."



# Live Safe: Counselling and Support for Women

Our counselling program for women is based in a trauma informed framework with a focus on recovery, autonomy and independence. Women have opportunities to be involved in therapeutic programs at Alice House during their time living here and beyond.

### The following options were offered last year.

- One on One Trauma Counselling
- 'Beyond Trauma' Group Counselling
- Women of Wonder (empowerment & self esteem)
- Grounding and Coping Workshops
- Peer Support Group
- Healthy Communications and Boundaries Workshop
- Trauma Informed Yoga
- Budgeting and Financial Management
- Boxing

# Alice on the Go!

This program is an independent work from home information and recovery model where women who have experienced domestic violence, can work through a program, at their own pace, with supports when they need it. It enables women who are working or in school full time or have other obligations that render them unavailable during group counselling days and times.



### In 2018-2019:

- 68 women were provided counselling services.
- 273 counselling sessions occurred.
- 40 Therapeutic Group Sessions delivered.
- Crisis support and advocacy occurred on 496 occasions.
- In 2018-2019, 100% of women that lived at Alice House did not return to their abusive partner.

"There is a stigma associated with women fleeing abuse. My own counselling and group work helped me maintain my mental health."

"There are no words for how much the support from Alice House has meant to me. To hold out their hand when you're at your absolute end. It saved my life."

"I learned that I was stronger than I thought I was and that I could do anything I put my mind to. This group has made me realize I am not alone."

" I used to be scared at night, but now I feel safe". 12 year old girl

"I had never lived on my own before and didn't think I could do it. Alice House helped show me that I could do it and that it's OK to ask for help sometimes. I am proud of what I have accomplished here. I will never go back into a home where there is abuse." 24 year old woman

" I didn't know what safety felt like. Home shouldn't be where you are most afraid. I understand that now that I know what it feels like to have somewhere safe to live." 31 year old woman

"My worries used to be in my heart but now they are in the sky". Age 7

"When I lived at home before, I was always sacred and worried about what was going to happen. I am glad I was able to talk about that and that I am not that scared anymore." Age 12

"My sleep is good now. I don't have bad dreams anymore" Age 8

# Healing Hearts: Counselling and Support for Children & Youth.

Healing Hearts (formerly know as Healing the Bruises) is for children and youth from the ages 4 to 18 years old. Children exposed to domestic violence need to have hope and opportunity for life to feel safer.

This trauma informed counselling program for children and youth provides an opportunity to learn, heal and grow. The children leave this program with a stronger understanding of what abuse is and an understanding it's not their fault. Their healing is also enabled through their own confidential conversations with a counsellor and parenting support and coaching for their mother.

### In 2018-2019

- 61 children received counselling and support.
- 26 children participated in group learning and art therapy.
- 42 women received parent coaching and support.
- Transportation provided to mothers and their children on 270 occasions.



### Tiers

### SAFETY (Turtle) - 2 Months

Weekly sessions, family counselling, higher level of parent counselling and support, higher level of advocacy with community partners. Assessing the impact of trauma on daily functioning.

- · Establishing safety.
- · Beginning to develop emotional vocabulary.
- Beginning to develop coping and grounding skills.
- Beginning to discuss the cycle of abuse and trauma symptoms.

### COURAGE (Elephant) - 5 Months

Bi-weekly sessions, family counselling, continued parent counselling and support, advocacy.

- Further developing emotional vocabulary to promote the expression of emotions.
- Developing a deeper understanding of the cycle of abuse.
- Exploring changes to family structure and family dynamics.
- Discussing the impact of trauma on self-esteem and sense of belonging.
- · Establishing and utilizing coping and grounding skills.

### GROWTH & OPPORTUNITY (Dragonfly) - 8 Months

Monthly sessions, family counselling, parent counselling and support, referral to outside resources.

- Redefining child/youth's sense of self, and supporting insight into improved self-esteem.
- Supporting child/youth's independence with emotional regulation, as well as coping and grounding skills.
- · Re-assessment of the impact of trauma on daily functioning.



# **Education and Advocacy**

Alice House envisions a society in which every person can live a life without the fear of physical, sexual, emotional, financial, social, or spiritual abuse. This means preventing intimate partner violence before it begins.

### In 2018-2019

- We presented to 1205 students and youth on recognizing signs of abuse in relationships.
- Delivered 48 awareness presentations across private sector, community and governments groups reaching over 1400 individuals.
- 42 individuals completed our SmartAlice Certification training.

### **Domestic Violence Court Support**

Alice House is proud to be a part of the Halifax Domestic Violence Program. With funding from the NS Department of Justice Alice House has been providing support



services to female victims going through the domestic violence court. This is an invaluable resource for women. We have provided support and advocacy that's included; access to housing, safety, child care, child support, child protective services, facilitated feedback to the court, counselling, food security and community connection.
