

We provide opportunities for women and their children to create a life free from intimate partner violence by offering safe housing, counselling, and support services.

We strive to ensure our clients and staff are physically and emotionally safe to enable healing, growth and realizing their potential.

We embrace diversity, support inclusion, and take conscious steps to increase equality, and create respectful environments for our clients and staff.

Safe Housing Update

Alice House has 18 safe house units made available to women and their children fleeing violence. Our houses and apartments are confidentially located and equipped with enhanced security features including perimeter cameras, 24-hour alarm monitoring and kick proof doors. These homes are made available to women 60% below market rate. They include lawn-care, snow removal, heat, water and internet. We enter into a lease agreement with the clients as a way to build a credit and landlord history with these families who are starting over.

For the 1st time ever, we connected Wi-Fi in all Alice House safe housing units. We also provided 18 Chromebooks so that women and children could stay connected and access the support they needed during the pandemic.



Capital repairs invested in our units

- Upgraded paint on unit doors and common room of 8-unit building
- Upgraded light fixtures from incandescent to power saving LED in 10 units
- Excavate and pave deteriorating driveway and replace storm damaged eavestrough and downspouts at 4-unit building
- Installed whole-home dehumidifier in below ground unit
- Replaced 5 aging fridges and 3 aging stoves
- Bathroom renovations in 4 units
- Capital repairs are financially supported by Royal LePage Atlantic, because of their support, we were able to make these investments over the past year.

Support Services Update

For the 1st time, our support services went online due to COVID-19. While this was part of our pandemic response plan, we will continue to offer virtual support services as an option post-pandemic.

Counselling and Programs for Women

Trauma Counselling

- 35 women received trauma counselling, over 600 sessions
 - » Trauma counselling is a type of professional help that explores the event(s) that led to and the emotions associated with the trauma in a safe and supportive setting. Trauma counselling often offers grounding practices and other exercises to help survivors feel safe while processing with a professional who is experienced in relevant traumatic experiences, like domestic or intimate partner violence.

Food Security

- 160+ food boxes were delivered to women and children
- 25 women access the food bank and essential supplies on a weekly basis
 - » COVID-19 imposed many challenges for our vulnerable populations, one challenge being food security and access. At Alice

House, we offered food bank access and essential supplies 4 days a week. For some of the women we serve, this wasn't enough because they were caring for their children during a lockdown and heavy restrictions. To fill this gap, Alice House team members were grocery shopping for some of the women and delivering food boxes to doorsteps and curbs.

NEW PROGRAM: Economic Independence Program (EIP)

- Since the launch of this program, all women who start their journey with AH, enroll in EIP as part of the reclamation of their independent lives.
- This new and innovative program grew from a recognized need. Women coming into Alice House have typically experienced financial and social abuse. The Economic Independence Program (EIP) was created to assist Alice House clients in developing skills to ensure economic independence and financial stability when they move on from Alice House. We discuss Credit 101, budgeting, and job readiness.







Housing Search and Retention Services

 Toward the end of their time living with Alice House, our clients are intensively supported with their housing search and with applications for long-term housing.

Transportation Support

- \$1754 = costs to cover taxis
- 100+ bus tickets distributed to those in need
 - » One of the barriers for women to access essential services is transportation. Alice House addresses that barrier by providing bus tickets and access to taxis to ensure they are getting the support and services they need.

Counselling and Programs for Children and Youth

Our Healing Hearts Program, for children and youth ages 4 to 18 years, is a trauma-informed counselling program that helps children process their feelings and heal from witnessing intimate partner violence. In addition to trauma-informed counselling for children and youth, we offer therapeutic play because play is essential for children to develop physically, emotionally, and socially. Therapeutic play is non-directive play therapy. It is a method of helping children with behaviour and emotional challenges and provides an opportunity to "play out" their feelings and problems.

Play Kits

- 103 play kits delivered to children and youth
 - One of the impacts of the COVID-19 lockdown was the shutdown of in-person schooling and other supports that are critical to children and youth like extra-curricular activities and therapy. Learning and other activities went online from home which required some creativity to ensure that kids and adolescents were engaged, stimulated, and having their needs met from home. It was important to us that our solution wasn't an added burden on mothers and caretakers.

Parenting Support Group

- 5 groups hosted with 32 parents, 9 children, and 15 YMCA staff
- 1. Parenting Support Group
- 2. Zones of Regulation
- 3. Baby and Toddler Group
- 4. Trauma-Informed Workshop

Alice on the Go

Alice on the Go is a 6-week, trauma-informed prevention and education program, built for women who face barriers to support due to work, school, childcare, transportation, or timing. Participants learn how to identify abusive behaviours, how to disrupt cycles of violence, & how to create healthy relationships.

55 women participated in Alice on the Go

Domestic Violence Court Support

This fiscal year, the Domestic Violence Court Program was held virtually, from case conferences to court sessions. Domestic Violence Court is piloting virtual court settings to be able to adjust more fluidly to shutdowns as experienced during COVID-19. Domestic Violence Court has allowed for counselling sessions and other services to run virtually, in-person (when allowed), or a hybrid of both.

Most Domestic Violence Court Support referrals come directly from Halifax Regional Police Victim Services.

55 survivors accessed Domestic Violence Court support services

Alice House attended 35 Domestic Violence
Court sessions and case conferences

Audited Financial Statements

Alice House: Financial Report as of March 31, 2021

Presented by David Davidson, Treasurer

It is my pleasure, on behalf of the Alice House Board of Directors, to present the Alice House Audited Financial Statements for the year ending March 31, 2021.

Summary

The auditors, Lyle Tilley Davidson Chartered Accounts, were able to provide a qualified opinion. The basis of the qualified opinion is consistent with not-for-profit organizations that are involved in fundraising. The "financial statements present fairly, in all material respects, the financial position of the Association as of March 31, 2021, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO)."

Statement of Financial Position

Alice House remains in a very healthy financial position. The assets of Alice House have increased over the previous year. The accumulated assets of the organization will allow for future investments to enhance Alice House's ability to meet its mission and to continue to enhance services to women and children facing domestic violence.

Statement of Revenue and Expenses

Alice House concluded the fiscal year with revenue in excess of expenditures by \$159,298.

Basis revenue and expenditures associated with the properties concluded the year with expenditures above revenue by \$41,779, driven by investments in property repairs and security.

Financial support from the community partners, private and public remains strong, and as a result Alice House was able to continue the growth and development of new programs and services.
